# Figtree – ANU Workplace Safety Incident & Hazard Reporting Tool

**Student Access Information Pack** 

### Background

Effective 3 April 2018, all undergraduate students will gain online access to Figtree, the University's safety incident and hazard reporting tool. The Supervisor role will be allocated to a Work Environment Group (WEG) representative who will then triage the incident or hazard to the relevant area for response. The relevant student Division/College will be allocated an action through Figtree to contact the student for follow up actions. Students will no longer be required to complete the paper based incident notification form. Figtree will replace the current process for incident reporting.


#### Why should students use Figtree



## Frequently Asked Questions (FAQ's)

What is Figtree?	Figtree is the University's workplace safety incident and hazard reporting tool. ANU launched the online system on 1 July 2017.	
What is a hazard?	A hazard is a situation that may currently exist or could arise out of a set of circumstances. There is a potential risk that the hazard may head to a dangerous situation.	
What is an incident?	An incident is an event that exposes a worker, student or any other person to a risk to their health and safety.	
What is a near miss?	A near miss is an incident where no one was injured.

How do I report an incident or hazard notification?	Refer to the <u>How to report an incident or hazard notification guide</u> online.	
Who will see the information that I enter into Figtree?	Work Health and Safety (WHS) Consultants/Officers will have access to the information entered in the online reporting tool. If other people are allocated an action, such as an incident investigator, then they will have access to view the incident record but not your injury details. Injury details can be viewed by you and WEG staff.

Who should I contact if I require an immediate response?	Students who require an immediate response following an incident should contact emergency services on 000 and/or ANU Security on 6125 2249. Tabled below are some examples of what students should report/not report using the online reporting system <u>Figtree</u>.

What should I report in Figtree? (Guide only)	What should I not report? (Guide only)
Identified hazards on campus	Vehicle damage Contact ANU Security on 6125 2249
Slips, trips and falls which occur on campus	Mobile phone/ other possessions stolen from backpack/handbag Contact ANU Security on 6125 2249
Lights out in building(s) or outdoor spaces posing danger to students	IT support issues Contact IT Service Desk on 6125 4321
Chemical spills/incidents in labs	Residential halls maintenance (not resulting in injury) <b>Contact Residential Advisors in your area</b>
Injuries on campus including residences	
Damaged property by natural causes, wear and tear and vandalism	
Electrical faults	
Traffic hazards (including pedestrian, cycling, motorists)	
Bullying and harassment	
Anything situation that potentially may cause harm to a student, staff or visitor of the University
